### 10 July 2017

### FIN.COM.17/17 Apologies for absence

Apologies were received from: Cllrs Lynch and Whipp. Cllr. Ayres was absent.

### FIN.COM. 17/18 Membership

Members noted that:

- a) Cllr. Quinn had stood down from the Finance Committee.
- b) Cllr's Connelly and Whipp had been invited to join the committee membership resolution ref: FIN.COM.17/14 and had accepted.

### FIN.COM.17/19 Minutes of the previous meeting

Members authorised the Chairman to sign the Minutes of the Meeting of the Finance Committee held on Monday 12 June 2017 as a true record, with the word "audited" crossed through under FIN.COM 17/11 and initialled by the chairman.

### FIN.COM.17/20 Declaration of interests and dispensations

Members were asked to disclose their interests in matters to be discussed and to decide requests for dispensations. None received.
