PL24/11 Declaration of Interests and Requests for Dispensations

PL24/14 W&F Local Plan – Way Forward

Members received a verbal update on Westmorland and Furness Council's proposal to review the Local Plan. The review will be commenced following the General Election with an 'early conversation'. A public drop-in session will be held in Penrith on Saturday 13th July between 10am and 2pm at Sainsburys to views of the public although an on-line questionnaire will also be available. The consultation questions at this stage will be broad and open ended and will focus on: Travel and Infrastructure, Health and Communities, People and Places, Economy and Climate and Nature.

Westmorland & Furness Council will also be doing a call for sites for residential and business development asking developers and landowners to submit sites for consideration. These sites will then be considered under the Strategic Housing and Economic Land Availability Assessment Process to start the narrowing down process. W&F will be required to have a 5-year land supply although the number of housing units has yet to be determined.

Westmorland and Furness Council Public Space Protection Order Frequently Asked Questions

What does PSPO mean?

PSPO is an abbreviation for Public Space Protection Order. A PSPO is a tool available to Councils under the Anti-Social Behaviour, Crime and Policing Act 2014 and are intended to be used to deal with a particular nuisance or problem in a specific area that is having a detrimental effect to the local community's quality of life, by imposing conditions on the use of that area which apply to everyone. They are intended to help ensure that the law- abiding majority can use and enjoy public spaces, safe from anti-social behaviour.

Why is an order restricted to a particular area?

The Anti-Social Behaviour, Crime and Policing Act 2014 states that proposals to introduce a PSPO need to focus on the impact that anti-social behaviour is having on victims and communities and meet defined legal tests.

A Public Spaces Protection Order can be made by the Council if they are satisfied on reasonable grounds that the activity or behaviour concerned, is carried out, or likely to be carried out, in a public space, and:

- has had, or is likely to have, a detrimental effect on the quality of life of those in the locality;
- is, or is likely to be, persistent or continuing in nature;
- is, or is likely to be, unreasonable; and
- justifies the restrictions imposed.

A range of information has been assessed and those areas which are deemed to meet the legal threshold are, subject to consultation, considered appropriate to be included in the PSPO. Areas within the Westmorland and Furness Council are that not included have been assessed as not meeting the required legal threshold at this time.

Are there time restrictions on a PSPO?

Restrictions set out within the PSPO will apply all day every day of each year the order is in force. The PSPO will last for three years and can be extended, amended or discharged, following a review.

What are the benefits to the community of a PSPO?

The main benefits of a PSPO are to help tackle the anti-social behaviours that are highlighted in the order. They are all aimed at making Westmorland and Furness Council area a safer and more pleasant place to inhabit as a resident or visitor.

Dogs on leads in specific areas.	To ensure safety and respect in some specific places, as well as the safety of wildlife and farm animals.
Dog on lead by direction.	To ensure safety of dogs, other animals and the public as above.
Dog Exclusion Area.	To ensure certain areas (children's play area/sports pitches, etc.) are safe for users and remain free from fouling.
Not to walk more than 6 dogs at any one time.	To ensure the welfare of the dogs, control for public safety and to restrict fouling.
No unauthorised fires or barbeques in all parks and open spaces owned by Westmorland and Furness Council.	To reduce the risk of wild-fires and damage to property and land, as well as reducing the risk of harm and inconvenience to others.
No drinking when asked to stop by an Authorised Officer.	To discourage or prevent people under the influence of alcohol from being anti- social and cause harm, alarm, distress or inconvenience to other members of the public or harm to themselves.

Anti-social behaviour by individuals or groups.	To prevent intimidation to others and undertaking of anti-social behaviour that impacts on others. This allows us to tackle this behaviour and help develop and maintain safer communities.
Driving or permitting a vehicle to be used in a manner that causes or is likely to cause harm, alarm and distress and/or danger.	This will help us to tackle a variety of issues, from vehicles/bikes/e-scooters being driven on council land without permission to vehicles being used in the community in a way that is causing or risks harm, alarm or distress, or risks of harm to persons or property.
No overnight camping/unauthorised encampments	This is to prevent harm or inconvenience to others, anti-social behaviour and damage (including environmental harm) and the tipping of waste. This order will help to control these issues, promote the use of authorised sites, and protect our landscape and the environment.

Anti-Social Behaviour Order in Practice

Would it be illegal to drink on the streets?

It would continue to be lawful to drink alcohol responsibly in a public place, subject to any other statute, by-laws or associated behaviours.

Can I be stopped or arrested for carrying alcohol on the streets?

This PSPO does not make it illegal to carry alcohol and is intended to be used to tackle alcoholrelated anti-social behaviour or disorder.

Under these circumstances Police Officers, or any authorised persons, will have the power to stop people who they believe are drinking alcohol and acting, or likely to act, in an anti-social manner and seize or confiscate alcohol within the area covered by the PSPO. Failure to comply with an officer's request to stop drinking and/or dispose of alcohol could result in receipt a Fixed Penalty Notice or a criminal prosecution.

Will the PSPO stop me from having an alcoholic drink with a family picnic?

No, the aim of the PSPO is to stop anyone who is committing anti-social behaviour through drinking alcohol. If someone is having a glass of wine with a picnic and this is not causing any anti-social behaviour then they will not be affected by this order.

The order is proposed at helping to deal with behaviours such as public intoxication, being rowdy and inconsiderate, swearing and shouting, urinating in the street and other behaviour which is considered to be detrimental to other users of public spaces and that, in the opinion of the enforcement officers, would make those people them feel uncomfortable or unsafe or otherwise have a detrimental effect on their use of that public space.

What about street parties and events in parks?

Events within a public place, which have an authorised premises licence, or a Temporary Event Notice (TEN) will be excluded from the PSPO powers during the time and in the place(s) for which the licence is approved.

Will there be any extra policing to enforce a PSPO?

The police and PCSOs will continue to patrol and respond to incidents as part of their community response, unless circumstances dictate otherwise. Authorised Officers will enforce the PSPO when required to do so.

Dogs

Where does the requirement to pick up after my dog apply?

The PSPO states that a person in charge of a dog must 'remove dog faeces from any land to which is open to the air and to which the public have access'.

It means that you must pick up your dog fouls/waste outdoors in parks and open spaces (including beaches), on the footpath, highway, bridleways and any other area which could be reasonably be expected to be accessed by the public. The order covers the whole of Westmorland and Furness Council area, although enforcement of the order will be predominately within areas where the impact is likely to be high, such as within the towns and in the parks and open spaces unless circumstances dictate otherwise.

Why might I be asked to put my dog on a lead?

Some dogs are generally safe and under control without a lead/leash. If an 'Authorised Officer' has formed the opinion that a dog has the potential to cause danger or a nuisance to other persons (or their dogs), the owner will be required to bring it under control by placing it on a lead. All dogs will be required to be placed on a lead in the Restricted Areas and there are some areas where dogs are generally forbidden to enter.

THIS ORDER applies to the public areas described in the Schedule to this Order ("the Restricted Areas").

2. Activity

2.1 Alcohol Consumption

2.1.1 It is an offence for anyone who, without reasonable excuse, fails to cease drinking and surrender any alcohol or hand over any containers (sealed or unsealed which are believed to contain alcohol), when required to do

- so by an Authorised Officer to prevent public disorder in the area identified in Schedule 1, save for the list of exceptions listed in Section 62 of the Act.
- 2.1.2 An Authorised Officer may intervene when they believe that the consumption of alcohol is or likely to cause harassment, alarm or distress to any other person, harm to the person concerned, or they believe that a person or persons consuming alcohol may be intoxicated or below the legal age for consumption of alcohol.

2.2 Anti-Social Behaviour

2.2.1 Challenging, threatening and other anti-social behaviour by groups or individuals that, in the opinion of the Authorised Officer, is causing or likely to cause harassment, alarm or distress to a person or persons, or otherwise disturb the peace or prevent the peaceful enjoyment of the area by others, within the area identified in Schedule 1.

3. Penalty

3.1 Alcohol Consumption

3.1.1 Failure to comply with the consumption of alcohol prohibition is a criminal offence, subject to a fine not exceeding Level 2 on the standard scale upon prosecution (£500). A warning may be issued upon the first instance of a breach. Further breaches will result in the issuing of a Fixed Penalty Notice. Payment of the Fixed Penalty Notice will discharge liability for prosecution for the offence.

3.2 All Other Breaches

3.2.1 Any breach of this order, without reasonable excuse, is a criminal offence and is subject to a Fixed Penalty Notice or prosecution. If a Fixed Penalty Notice remains unpaid after the time allowed by statue, then the offender will be liable for prosecution. On summary of conviction, an individual would be liable to a fine not exceeding Level 3 on the standard scale (£1000).

4. Appeal

- 4.1 Any challenge to this Order must be made to the High Court by an interested person within six weeks of it being made. An interested person is someone who lives in, regularly works in, or regularly visits the Restricted Areas. This means that only those who are directly affected by the restrictions have the power to challenge. The right to challenge also exists where an order is varied by the Council.
- 4.2 Interested parties can challenge the validity of this Order on two grounds:

- 4.2.1 That the Council did not have the power to make the order or variation, or to include particular prohibitions or requirements; or
- 4.2.2 That the Council has not complied with one of the requirements of the relevant legislation.
- 4.3Where an application is made the High Court can decide to suspend the operation of the Order pending the Court's decision, in part or in totality. The High Court has the ability to uphold the order, quash it or vary any of its prohibitions or requirements.

5. Supplementary and Definitions

- 5.1 An Authorised Officer for the purposes of this Order is a Police Constable, Police Community Support Officer, an Officer of the Council or any other person authorised by written authority of Westmorland and Furness Council to enforce Public Space Protection Orders on behalf of the Council.
- 5.2 In order to exercise their powers under this Order and, in particular, paragraph 2.1 above, Authorised Officers may seize and retain any item or material, believed to be evidence of a breach of this Order. They may dispose of any alcohol seized my means of pouring it away, where this is considered necessary and expedient.
- 5.3 Authorised Officers may make such records and take photographs as required, at their discretion, in order to evidence potential breaches of this Order.
- 5.4 An Authorised Officer acting to ensure compliance of this order will show their authorisation to any interested party upon request.
- 5.5 Key factors authorised officers will consider when taking action is where behaviour (or the behaviour of visitors or associates) causes, or attracts antisocial behaviour and/or has a detrimental effect on the quality of life of those in the area.
- 5.6 Parks and Open Spaces are defined as being those parts of the Restricted Areas as set out on the attached Schedules, that are designated or are historically used as children's play areas, areas designed for the playing of ball games, gardens, plant nurseries, ponds, woodland, etc., and other defined areas owned or managed by Westmorland and Furness Council that are designed for the leisure and recreation of residents and visitors.

- 2.1.1.3 fail to keep a dog on a lead at all times which has been designated as a dog on lead area, identified in Schedule 2;
- 2.1.1.4 fail to put a dog on a lead upon direction of an Authorised Officer in any of the Restricted Areas;
- 2.1.1.5 take a dog onto, or permit a dog to enter and remain on any land that has been designated as a dog exclusion area as identified in Schedule 3; and/or
- 2.1.1.6 individually walks more than 6 dogs at any one time, within the area identified in Schedule 1.
- 2.1.2 The provisions of this Order relating to the control of dogs shall not apply to any person who is either:
 - 2.1.2.1 in charge of a working dog whilst it is actually working, this includes dogs that are being used for work in connection with emergency search and rescue, herding or shepherding animals, law enforcement and the work of the armed forces; or
 - 2.1.2.2 is registered blind in accordance with section 29 of the National Assistance Act 1948, or suffering a disability and in sole charge of a dog trained to assist with his/her mobility, manual dexterity, physical coordination or ability to lift or carry everyday objects and the said dog has been trained by a prescribed charity.

- 5.4 Key factors authorised officers will consider when taking action is where behaviour (or the behaviour of visitors or associates) causes, or attracts anti-social behaviour and/or has a detrimental effect on the quality of life of those in the area.
- 5.5 Parks and Open Spaces are defined as being those parts of the Restricted Areas as set out on the attached Schedules, that are designated or are historically used as children's play areas, areas designed for the playing of ball games, gardens, plant nurseries, ponds, woodland, etc., and other defined areas owned or managed by Westmorland and Furness Council that are designed for the leisure and recreation of residents and visitors.

Any land in the administrative area of Westmorland and Furness Council open to the air and to which the public are entitled to access (with or without payment).
